1. Loss of employment or change in employment status
 - Statement of anticipated income from January 1, 2012 through December 31, 2012
 - Signed statement from the student/parent explaining reason for unemployment
 - Year to date pay stubs showing all income earned from work for 2012
 - Termination letter and/or any documentation regarding severance pay
 - Unemployment benefits statement
2. Divorce or separation
 - Divorce – copy of divorce decree
 - Separation – copy of legal separation agreement or signed statement from your attorney
3. Death of spouse or parent
 - Death certificate or an obituary notice
4. Unreimbursed medical or dental expenses for 2011
 - Copies of any large bills
 - Canceled checks or receipts showing amount paid with statement from insurance company showing expenses were not reimbursed
5. Other circumstances
 - Any relevant documentation which will support request for reconsideration
